- iv. The Principal, Dr. Debendranath Behera initiated the discussion & presented the detail account of various developmental activities undertaken and completed during the year.
- Syllabi recommended by various Board of Studies (UG & PG) under CBCS System were placed before the council for discussion and were approved.

3. Difficulties pointed out by the Members:

- Dr. (Mrs) Sasmita Samal, HOD Chemistry and Dr. Biswanath Parija, Asst. Professor, Physics narrated the difficulties in managing the department without non-teaching staff.
- Or. (Mrs) Basanti Kujur, Deputy Controller of Examinations, narrated the problems related to Examination Database Management without a System Analyst/System Administrator as the number of students has increased which leads to late result declaration also.
- Proposal given by Coordinator, Self-Financing regarding PPP mode of operation for Selffinancing courses was discussed.
- iv. Prof. Kichak Chandra Jena, Academic Bursar, pointed out the problems related to old students those are taking admission in PG Courses as they are more involved in other non academic works rather than academics and creating problems in college.

4. Suggestions made by the members.

- i. Regarding the difficulties in managing the departments without non-teaching staff, Dr. Iswar Prasad Mohanty, Administrative Bursar, suggested to write letters to appropriate authority in Higher Education Department of Odisha for posting adequate staff form the current session in order to maintain Common Minimum Standard and to impart quality education to the students. This suggestion was accepted unanimously.
- ii. Regarding the Examination Database Management of the students, Dr. Pravat Kumar Mallick Member, Academic Council, suggested to build a central database of the students for the smooth running of the Academics, Examination and other co-curricular activities of the college. He also suggested appointing a System Analyst/System Administrator having minimum MCA degree with minimum 10 years experience in teaching and software development. The system Analyst/System Administrator should also be responsible for the college website development, management and uploading of related information.
- Proposal given by Coordinator, Self Financing regarding PPP mode of operation for Selffinancing courses was not approved unanimously due to non availability of rooms and this will also lead to poor academic result.
- iv. Prof. Sanjat Kumar Sahoo suggested for publishing activity calendar for each year from the beginning of the academic session.
- Prof. A.K.Dasmohapatra suggested for publishing the paper discussed in the seminar conducted by the departments and as well in the consortia of journals approved by UGC.
- vi. Prof. A.K. Dasmohapatra and Prof. S. Dash proposed to make syllabus of Arts, Science & Commerce skill oriented to make the students professionally skilled so that the students can face challenges of globalization. In this context they also suggested to tie up with Odisha State Open University, (OSOU) Sambalpur for the benefit of students.
- vii. Prof. S.K. Sahoo insisted to make NAAC reaccreditation as early as possible to get funds from UGC. He also narrated the new and revised guidelines laid by UGC for NAAC reaccreditation.
- Advocate Sadananda Sahoo suggested holding meetings/ seminar/ workshops/ conference for awareness regarding the legal matters in the college.
- ix. All members suggested to conduct Workshops/ National & State Level Seminars in the college for the betterment of the stake holders. They also discussed about the feedback information from the stake holders.
- Academic Bursar suggested for forming of Students' Council instead of Students' Union
 and placed the resolution of Staff Council Meeting dated 21.01.2018 for approval.
