Proceedings of the meeting on "Introduction of Choice Based Credit System (CBCS) in all Autonomous Colleges" and "NAAC accreditation in all eligible Colleges of Odisha" under the chairmanship of Principal Secretary, HE Dept. at Hotel Swosti Premium on 24/07/15 at 10.00 am.

A one-day workshop on "Introduction of Choice Based Credit System (CBCS) in all Autonomous Colleges" and "NAAC accreditation in all eligible Colleges of Odisha" was conducted by the Higher Education Department on 24.07.2015 at Hotel Swosti Premium. Principal Secretary of Higher Education Department presided over the meeting. Vice-Chancellors/OSDs of all eleven State universities, Principals of 37 autonomous Degree colleges and 15 NAAC accredited mentor colleges were present in the meeting. Prof.Venketesh Kumar of TISS, Mumbai was also present. The list of members present is at Annexure-A.

Dr. Ajay Ku. Nayak, Joint Secretary welcomed all the participants and explained the objectives of the workshop. The Principal Secretary thereafter delivered on different reform processes taken up by the department during last two years and stressed upon the adoption of CBCS in all the Colleges, as UGC has given direction that all the University and Colleges must adopt CBCS from the current session 2015-16. Further, UGC has fixed the dateline 31st December, 2015 as the last date of applying for accreditation /re-accreditation, otherwise the UGC grants will be stopped from 1st April, 2016. As per the recent directive of NAAC, from 1st August, 2015, the HEIs have to upload the Self Study Report (SSR) first and then only Letter of Intent (LOI) can be submitted. Hence, a detailed discussion on these two aspects was made in the meeting.

(A) Choice Based Credit System(CBCS)



Prof. R.K. Bal, Chairman , P.G. Council, Utkal University made a power point presentation and explained the detailed features of CBCS of total 140 credits through Power Point Presentation. He along with Prof. Ashok Ku. Das ,Vice – Chancellor, Utkal University and Prof. Siba Prasad Adhikary, Vice-Chancellor, F.M. University clarified the doubts on CBCS and all were of the opinion that CBCS must be adopted at UG Level as it allows the students a lot of flexibility in choosing the subjects .

All the Universities agreed to adopt CBCS from 2015-16 in the Autonomous Colleges, as they have semester system in place and have own examination. System.

All agreed to implement the syllabi framed by Utkal University. The C.D.s containing the detailed syllabus, UGC guidelines on CBCS etc. were distributed among the universities and Colleges.

(B) NAAC accreditation/re-accreditation:

UGC has made NAAC accreditation mandatory for all Govt./Aided Degree Colleges. As a first step, all colleges were asked to submit LOI by 30.07.2015 to the NAAC to be eligible for NAAC Accreditation. 15 Colleges were declared as NAAC mentor colleges (facilitation centers) for peripheral colleges of concerned area (a total number of 225 colleges) to guide and ensure submission of LOI by 30.07.2015. The Mentor colleges were requested to call a meeting of their attached colleges within two days and get the draft LOI ready by 25.07.15 and ensure its submission to the NAAC authorities by 30.07.15 positively. A contingency fund for organizing the training and facilitation works @ Rs. 20,000/- per mentor college was provided for



the said purpose. Regular monitoring by Higher Education Department is being made in order to keep a track of NAAC accredited colleges.

(c) RUSA:

Prof. Venkatesh Kumar, TISS, Mumbai appreciated the reforms undertaken by Govt. of Odisha during last 2 to 3 years and also the steps taken for implementing RUSA components very sincerely and effectively. He informed the house that Odisha now tops among all other States of the country in this effort. He emphasized that leadership development programmes to be taken up very seriously in the state of Odisha in the coming days. Prof. Venkatesh Kumar sought the views from the Vice- Chancellors regarding the amendment of the Acts/Policies concerning higher education.

The meeting ended with vote of thanks to all the participants and the Chair.


